ÖGRAB´s use of your personal data

We care about protecting your personal integrity. It is necessary for us to store and handle your personal data in order for us to process your application/registration. The purpose of the collection and processing of your personal data is for us to fulfil our obligations.

The personal data that we store about you is data that you provided us with when registering. Personal data is always processed in compliance with legislation that apply to personal data. The legal basis for processing your personal data is in this case the exercise of authority. Your personal data will be stored and deleted according to the company´s information-/archiving procedures.

The personal data we process about you is shared with external parties applicable to fulfil our obligations. Therefore, we might share your personal data with a third party provided we are under legal obligation to do so. However, we will never transfer your data to a country outside the EU, unless subject to exemption from the General Data Protection Act (GDPR).

At ÖGRAB, the board of directors is the data controller. You have the right to contact us if you wish to request access to the information about the personal data we have about you, to request correction of errors in your personal data, to request transferring of your personal data or to request restriction of processing of your personal data, to object to the processing of your personal data or to request erasing of any personal data not needed. You may submit a request by using a Privacy Contact Form. You need to hand in your request in person at ÖGRAB i Kattarp, please bring a valid proof of identity.
